# Swiss Life Investment Foundation Equities Foreign ESG Indexed

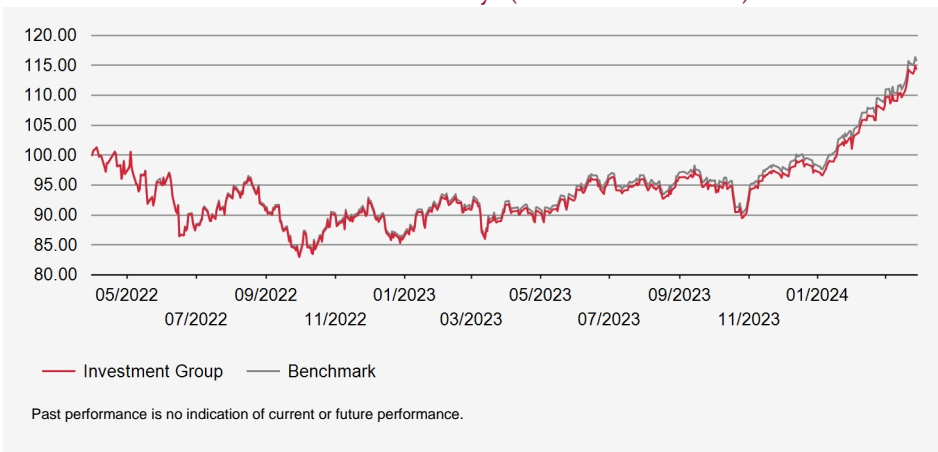

## Evolution in reference currency (base value 100)



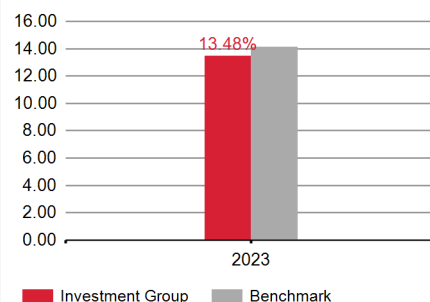
